LEARNING JOURNEY – 18 Months

Unit 1 – Health & Wellbeing (4 weeks)

This unit focuses on:
Health and wellbeing for babies and children and the need for exercise, rest and sleep. It will also consider childhood immunisation and its importance.

Unit 3 – Emotional Wellbeing & Healthy Lifestyle (4 weeks)

This unit focuses on:
Children and how they form attachments, how transitions and significant events can affect attachments and ways to support children through transitions and significant events.

Unit 5 – Patterns of Development (4 weeks)

This unit focuses on:
Patterns of development in children from birth to seven years of age including speech, language and communication development and personal, social and emotional and physical development.

Unit 7 – Observation & Assessment of Children's Development (4 weeks)

This unit focuses on:
The holistic development of a child's: - speech, language and communication -personal, social and emotional development - physical development

Unit 2 – Policies & Procedures (4 weeks)

This unit focuses on:
Legislation within the early years sector including health and safety, and the need for confidentiality and child welfare.

Unit 4 – Continued Professional Development (4 weeks)

This unit focuses on:
Continued professional development, its importance, types of CPD you can undertake and how this can improve employee performance.

Unit 6 – Theories & Philosophical Approaches (4 weeks)

This unit focuses on:
Theories and philosophical approaches and their influences on children's learning and development.

Unit 8 – Diversity, Equality & Inclusion (4 weeks)

This unit focuses on:
Equality, diversity and inclusion including cultural differences and family circumstances.

Unit 9 – Safeguarding (4 weeks)

This unit focuses on:
Safeguarding and the policies and procedures governing it, child abuse risk factors and child protection strategies.

Unit 11 – Working in Partnership (4 weeks)

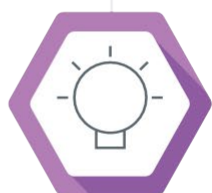
This unit focuses on:
The legal requirements and guidance on confidentiality of information when working with others

Unit 13 – Value of Play in Early Years (4 weeks)

This unit focuses on:
A range of underpinning theories and philosophical approaches to how children learn and develop, and their influence on practice.

Unit 15 – School Readiness (8 weeks)

This unit focus on:
The potential effects of, and how to prepare and support children through, transitions and significant events in their lives.



Unit 10 – Health & Safety and Enabling Environments (4 weeks)

This unit focuses on:
The legal requirements and guidance on health and safety, security, and safeguarding and promoting the welfare of children.

Unit 12 – Additional Support Needs (4weeks)

This unit focuses on:
Providing the child with additional support where progress is less than expected using a range of assessment techniques .

Unit 14 – Developing Literacy & Mathematical Skills (4weeks)

This unit focus on:
The current early education curriculum requirements such as the Early Years Foundation Stage.

Unit 16 – Mock Assessments and Unit 17 – CPD Development Plan for EPA (8 weeks)

Activities towards progressing through gateway to complete End-Point Assessment (EPA).
